Rollin Township Information

Rollin Township has ordinances in effect concerning all types of construction. Please contact the appropriate inspector before remodeling or beginning any new construction. If construction or electrical work is started before proper approval and permits are obtained, you may be billed an additional fee.

An important governing ordinance requires each residence to display three inch or larger house numbers on the premise so they are visible from the road. This ordinance enables fire, police and rescue workers to identify all premises.

Lawns in residential districts must be kept mowed. Any lawn more than 10 inches in height may be mowed by the township with the cost of mowing added to your tax bill. This amount becomes a lien against the property.

Refuse must be removed on a regular basis. You can contract with one of the refuse collection agencies that serve the Township area or take your refuse to one of the local disposal sites (Modern Waste in Napoleon or Liberty Land Fill in Clark Lake)

Winter Property Tax Collection

Winter taxes for 2020 will be collected at the Rollin Township Hall beginning December 1, 2020 during the following times: Tuesdays: 4pm until 7pm
Thursdays: 7am until 3pm

Payments can always be placed in the drop box located on the East side door of the Township hall. If you choose to pay by mail, please send your tax coupon and payment to:

If you mail the tax payment or place the payment in the drop box & you wish to have a receipt, please write a note. Due to the current COVID-19 Pandemic, we will mail you a receipt.

Taxes are due February 14, 2021. A 3% penalty may be added to tax payments made after that date. Payments will be accepted at the Township through 4pm on Monday, March 1, 2021. Payment must be postmarked by February 28th.

Payments mailed on or after March 1st cannot be accepted by Rollin Township; Payment must be sent to the Lenawee County Treasurer's Office at 301 N Main Street, Adrian MI 49221 (Phone: #517-264-4554)

Dog license payment needs to be on a separate check from taxes. They are available at the township hall through Oct 31st each year.

Please examine your tax bill carefully

Note: A penalty exists for claiming a principal residence exemption if you are NOT entitled to the exemption.
